Summary:

4. Support the annual budget process including creation of financial models and budget presentation and explanation
5. Assist in the preparation of financial plans and analysis of consolidated trends
6. Prepare monthly covenant reporting for financial institutions
7. Perform market-specific economic research to identify major business trends and analyze issues impacting company financial and operational performance
